The Dodge County Board of Commissioners met in a regular session at 6:00 p.m. on Monday, May 4, 2015, in Suite 101 of the Dodge County Courthouse Annex.

Chairman McCranie called the meeting to order and led those present in the Pledge of Allegiance to the American flag. Commissioner Niblett prayed.

#### **Elected Officials/ Department Heads**

Chairman McCranie recognized Henry Whitfield, Director of the Cochran and Eastman campuses of Middle Georgia State College who addressed the board about good news concerning the institution. He said the school would receive university status effective July 1, 2015. He said there would be Homecoming celebrations on all five (5) campuses and the Eastman campus will host an air show on Saturday, September 12. He said the details were still being finalized for the event but he expected it to begin around 9 or 10 a.m. with guests associated with the aeronautics industry. He said he had already met with City of Eastman officials including Raymond Mullis and Bea Edge and asked for their support of in-kind services for the event including police and traffic control. He said he would also be asking the county for help in those areas. Chairman McCranie thanked him for coming and Commissioner Niblett commented that he was excited about the news.

A. April 20, 2015 Regular Meeting

Chairman McCranie asked for any additions, corrections, or deletions to the minutes of the regular meeting held on April 20, 2015 and presented to the board in printed form. A motion was made by Commissioner Howell to approve seconded by Commissioner Niblett. The vote was unanimous to approve.
