# **B. Aging Advisory Committee Appointees**

Commissioner Flanagan made a motion to table the appointments due to the absence of Commissioner Cheek. Commissioner Belflower seconded the motion to table. All voted in favor, and the matter was tabled.

## C. Gresston Dump Site

Manager Bearden was requested to ascertain if the cameras are capable of recording time, date, and location.

# D. Limb/Leaf Debris Mulching Bids

Commissioner Watkins made a motion to accept the lowest bid meeting qualifications for one event, which was from LRS Land Services. Commissioner Flanagan seconded the motion. All voted in favor, and the motion passed.

- LRS Land Services \$8,500 per event, totaling \$34K annually
- AKA Tree Services \$9,750 per event with conditions, totaling a minimum of \$39K annually
- Conley Construction did not meet qualifications of the bid
- MW Collins \$25K per event, totaling \$100K annually

# E. Tax Assessor Mapping Quote

Commissioner Belflower made a motion to approve the bid from EagleView with Change Finder in the amount of \$25,938.92. Commissioner Flanagan seconded. All voted in favor, and the motion passed.
