Dodge County Board of Commissioners Board Meeting Minutes Monday, November 20, 2023 at 6:00 p.m.

The Dodge County Board of Commissioners held their regular meeting at the Dodge County Pearl Bates Courthouse Annex Monday, November 20, 2023, at 6:00 p.m. with Chairman McCranie presiding. He called the meeting to order and led the Pledge of Allegiance. Commissioner Cheek gave a devotion, entitled "A Thanksgiving Blessing," and led a prayer.

Elected Officials/Department Heads

- Fire Chief Jamey Wilkinson presented the incident response report noting 66 calls for the month of October.
- EMS Director updated total revenues of \$91,996.85 for the month of October. Through October, the EMS responded to 4,170 calls. Also, two new ambulances should be arriving in December.

Approval of Minutes

A. Minutes – November 06, 2023 Regular Meeting

Commissioner Watkins made a motion to approve the regular meeting minutes with no amendments. Commissioner Flanagan seconded. All voted in favor, and the motion passed.

B. Minutes - November 13, 2023 Work Session

Commissioner Belflower made a motion to approve the work session minutes with no amendments. Commissioner Cheek seconded. All voted in favor, and the motion passed.

Old Business

A. Hobbs Road

Commissioner Watkins made a motion to proceed with public hearings, coinciding with the next two board meetings on December 4th and 18th, for the purpose of abandoning Hobbs Road. Commissioner Flanagan seconded. All voted agreeably, and the motion passed.

B. Approval of FY 2022 Audit

A motion was made by Commissioner Belflower and seconded by Commissioner Watkins to approve the FY 2022 County Audit. All voted in favor, and the motion passed.

New Business

A. Approval of Accounts Payable

A motion was made by Commissioner Belflower and seconded by Commissioner Watkins to approve the accounts payable report totaling \$191,086.90. All voted in favor and the motion passed.

B. E911 Restricted Fund Bank Account (continued after line item L)



Commissioner Watkins requested Attorney Harrington draft a resolution to open the E911 Restricted Fund Bank and to readdress this item later in the agenda.

C. 2024 LMIG Approval

H. Golden Isles Greenway Resolution

Commissioner Belflower made a motion to approve the Golden Isles Greenway Resolution, as recorded below. Commissioner Flanagan seconded. All voted in favor, and the motion passed.

WHEREAS, Secure funding and approval for the completion of a four-lane highway between the intersection on Highway 96 and Highway 87 /23 and Interstate 16 (Exit 6) will benefit future development and increase in the transportation of goods, strengthen tourism on the Golden Isle Parkway, and support the Ocmulgee Mounds National Historic Park;

WHEREAS, it would be advantageous for official corridors to be established for the pursuit of state and federal grants, and;

WHEREAS, the Golden Isle Greenway Corridor shall be composed of the following two contiguous parcels:

J. Regional Council 3rd Member Appointment

The Regional Council Third-member noted by the board for appointment at the next scheduled meeting.

K. 2024 Proposed Budgets

Commissioner Flanagan made a motion to set the public hearings to discuss the proposed 2024 county budgets, along with the fiduciary accounts, on December 4th and December 18th to coincide with the next regularly scheduled board meetings. Commissioner Cheek seconded. All voted in favor, and the motion passed.

L. Tax Assessor Board Appointment

After confirming this was the 2nd meeting this appointment has been on the agenda, thereby following the board's policy for board appointments, Commissioner Flanagan made a motion to nominate Cindy Eckles to the Board of Tax Assessors. (Eckles was the only application submitted after advertising for one month.) Commissioner Cheek seconded the nomination. No other nominations were forthcoming. Commissioner Cheek made a motion to close nominations. Commissioner Flanagan seconded. All voted in favor, and the nominations were closed.

Chairman McCranie announced Cindy Eckles was appointed by acclamation.



B. E911 Restricted Fund Bank Account (continuation from above)

Attorney Harrington read aloud the following resolution to set the E911 Restricted Fund Bank Account:

A RESOLUTION

TO CREATE A SEPARATE RESTRICTED BANK ACCOUNT FOR THE COLLECTION AND DISBURSEMENT OF FUNDS FOR MONIES RECEIVED BY VIRTUE OF 911 FEES REQUIRED BY THE STATE

WHEREAS, it is resolved by the Dodge County Board of Commissioners that a bank account be established for the purpose of collecting and disbursing fees received from 911 assessments; and

WHEREAS, it is resolved that all checks issued on said accounts shall require two of the following persons signature on the face of the check: William Dan McCranie – Chairman, Conner Bearden – County Manager, and Kimberly Smith-Parkerson – County Clerk or their successors over time as they appear and are elected or appointed.

The County Manager is therefore directed to create said account at the Colony Bank in Eastman, GA, and to have signature cards set up on said account.
