## Call to Order

The Dodge County Board of Commissioners held a regular meeting at the Dodge County Pearl Bates Courthouse Annex Monday, May 19, 2025, at 6:00 p.m. with Chairman McCranie presiding. He called the meeting to order and asked for a motion to amend the agenda to add an executive session for legal matters after public comments. Commissioner Watkins made a motion with Commissioner Jones seconding. All voted in favor, and the agenda was amended. Next, Chairman McCranie led the Pledge of Allegiance and gave a devotion. His devotion was from 2 Kings 2:2 and entitled "Good Grief." Afterward, Chairman McCranie led a prayer.

## **Elected Officials/Department Heads**

## A. EMS Director Michael Johnson

EMS Director Johnson reported 366 calls in April with revenues of \$111,258.22. He also reported that the two new ambulances were finally in Dodge County's possession.

## B. Fire Chief Jamey Wilkinson

Fire Chief Wilkinson reported 78 calls in April with 413 for the year. He also reported \$3,972 in collections.

## A. Minutes - May 05, 2025 Regular Meeting

Commissioner Jones made a motion to approve the minutes with no additions, corrections, or deletions. Commissioner Greene seconded the motion. All voted in favor, and the motion passed.

#### **New Business**

## A. Approval of Accounts Payable

Commissioner Jones made a motion to approve the accounts payable report totaling \$163,912.07. Commissioner Watkins seconded the motion. All voted in favor, and the motion passed.

#### B. Eastman Garden Club - Blue Star

Commissioners Flanagan made a motion to allocate \$600 to the Eastman Garden Club for the purchase of a Blue Star Memorial Highway Marker. Commissioner Watkins seconded the motion. All voted in favor, and the motion passed.

#### C. Healthcare Broker

Manager Bearden reported receiving seven responses to the RFP for a healthcare broker for county benefits. He also stated the healthcare committee had narrowed the choice to three: Capstone, Mark III, and MSI benefits.

## D. 2025 Local Road Assistance Administration (LRA) Funds

Manager Bearden presented the 2025 LRA list as recommended by the road committee (below). Commissioner Jones made a motion to approve the list as presented. Commissioner Greene seconded. All voted in favor, and the motion passed.
