Board Meeting Minutes

Call to Order

The Dodge County Board of Commissioners held a regular meeting at the Dodge County Pearl Bates Courthouse Annex Monday, November 03, 2025, with Chairman McCranie presiding. He called the meeting to order at 6:00 p.m. and led the Pledge of Allegiance. Next, he led a prayer.

Elected Officials/Department Heads

Nothing presented.

Approval of Minutes

A. Minutes – October 20, 2025 Public Hearing

Commissioner Watkins made a motion to approve the minutes with no additions, corrections, or deletions. Commissioner Flanagan seconded the motion. All voted in favor, and the motion passed.

B. Minutes – October 20, 2025 Regular Meeting

Commissioner Jones made a motion to approve the minutes with no additions, corrections, or deletions. Commissioner Greene seconded the motion. All voted in favor, and the motion passed.

C. Minutes – October 29, 2025 Work Session Meeting

Commissioner Greene made a motion to approve the minutes with no additions, corrections, or deletions. Commissioner Watkins seconded the motion. All voted in favor, and the motion passed.

D. Minutes – October 30, 2025 Called Meeting

Commissioner Flanagan made a motion to approve the minutes with no additions, corrections, or deletions. Commissioner Greene seconded the motion. All voted in favor, and the motion passed.

Old Business

A. Solar and Battery Energy Storage Facility Ordinance

Commissioner Jones made a motion to approve the Solar and Battery Energy Storage Facility Ordinance and to end the moratorium from the meeting on August 18, 2025. Commissioner Watkins seconded the motion. All voted in favor, and the motion passed.

B. Coleman Road

Manager Bearden clarified that the Coleman Road abandonment had been suggested by the county manager due to a request to end county maintenance on that roadway. No motion was made to abandon the road.

New Business

A. Approval of Accounts Payable

Commissioner Flanagan made a motion to approve the accounts payable report totaling \$134,214.89. Commissioner Jones seconded the motion. All voted in favor, and the motion passed.

B. Courthouse Committee Project Update

Chairman McCranie stated the full board should serve on the courthouse committee due to the

magnitude of the project. Commissioner Flanagan updated that the committee had been working to refine rough floor plans. Parrish was confirmed for a meeting on Tuesday at 11 a.m.

C. Emergency Services CAD Texting

Commissioner Watkins made a motion to approve CAD-to-text through IamResponding for fire and EMS. Commissioner Jones seconded the motion. All voted in favor, and the motion passed.

D. Underground Fuel Storage Repair

Commissioner Watkins made a motion to utilize WEX cards and discontinue the use of the underground fuel tank and the fuel monitoring system. Commissioner Jones seconded the motion. All voted in favor, and the motion passed.

E. Facilities Authority Applications

Manager Bearden presented applications from Jason Braden, Mark Doss, and Jason Hersey for the Facilities Authority Board.

F. FY '25 Third Quarter Financial Statement

The third quarter financial report was reviewed by the board.

G. Dr. Lydia Daniels – Pecan Lane

Dr. Lydia Daniels petitioned the board for the classification of Pecan Lane as a “public road.” Signatories and details attached.

J. Oconee Drug Task Force CJCC Intergovernmental Agreement

Commissioner Watkins made a motion to approve the Oconee Drug Task Force/Middle Georgia Gang Task Force Intergovernmental Agreement, which details a collaborative crime control initiative to rid communities of illicit drugs, gangs, and other criminal activity. Commissioner Flanagan seconded the motion. All voted in favor, and the motion passed.

Commissioner Greene made a motion to approve the Dodge County and City of Eastman Memorandum of Understanding for the shared cost of a sheriff's deputy assigned to the Oconee Drug Task Force. Commissioner Jones seconded the motion. All voted in favor, and the motion passed.
